Meeting was called to order by Eric at 8:46 am with all Directors present.

Please note that all references to exhibits herein refer to the exhibits attached to the Agenda or attached hereto. Our Club Foundation is referred to as the "Foundation" or the "LJGTRCF."

- 1. M/S/C to ratify the Board's prior approval of both the Minutes of Board Meeting of December 7, 2018 (Exhibit 1a) and the Minutes of the Annual Meeting of the Membership of the Foundation of May 31, 2019 (Exhibit 1b). Board packet incorrectly included wrong minutes. Board had previously approved correct minutes and subsequently to the meeting confirmed prior approval of correct minutes. The correct Exhibit 1b which are the correct minutes for the 5-31-19 meeting is attached hereto as Exhibit "A".
- 2. After explanation by Treasurer Russell and President Brown, the Board reviewed, and had no objections to, or questions about, **Exhibit 2**. **Exhibit 2** is a one page Summary of the Foundation Account Balances as of June 30, 2019.
- **3.** The Board reviewed, and had no objections to, or questions about, **Exhibit 3a** which is the 2019-2020 Club Avenue of Service Projects Fund Allocations by the

Foundation which specifies the Club's Avenues of Service ("AOS") expenditures. The Board reviewed, and had no objections to, or questions about, **Exhibit 3b** which specifies the Unspent funds by the Club's AOS expenditures.

- **4.** The Board reviewed, and had no objections to, or questions about, **Exhibit 4a** which is the Profit and Loss Detail for the General Checking Account maintained by Pam for <u>July 1, 2018 through June 30, 2019</u>. The Board reviewed, and had no objections to, or questions about, **Exhibit 4b** which is the Register Report for the General Checking Account maintained by Pam from <u>July 1, 2018 through June 30, 2019</u>. The General Checking Account is for (i) the deposit of members' contributions to the Rotary Foundation, (ii) funds to be added to our endowment, and (iii) funds earmarked for next year's projects.
- 5. The Foundation has a second checking account maintained by Steve Brown known as the Special Projects Checking Account. The Special Projects Checking Account is for donations that have been earmarked to specific projects, fundraising outside the club, and an occasional Global Grant. While there are separate Checking Accounts both accounts are maintained at Torrey Pines Bank, Exhibits 5a, 5b, 5c and 5d illustrate accounting details for the Special Projects Account by different methods. The Board reviewed, and had no objections to, or questions about, the Special Projects Checking Account from July 1, 2018 through June 30, 2019 which specifies *chronological* payments and deposits (**Exhibit 5a**). The Board reviewed, and had no objections to, or questions about, the Itemized Categories Summary of the Special Accounts Checking Account which itemizes all expenditures and deposits by Project from the period of time 7-1-18 to 6-30-19 (Exhibit 5b). The Board reviewed, and had no objections to, or questions about, **Exhibit 5c** which details the Special Projects Checking Account by *Project* from 1-1-90 through 6-30-19. The Board reviewed, and had no objections to, or questions about, Exhibit 5d which is an accounting of any projects receiving in excess of \$5,000 from July 1, 2018 through June 30, 2019.
- **6.** After explanation by Pam Russell, the Board reviewed, and had no objection to, or questions about, the Foundation 2018-19 Final Report (**Exhibit 6**).
- 7. After explanation by Pam Russell, the Board reviewed, and had no objection to, or questions about, **Exhibit 7a** which constitutes the Treasurer's Annual Report on involvement of club members for the time FY 2018-19 by specifying (i) New Paul Harris Fellows; (ii) Members of the Paul Harris Society; (iii) Rotary—Direct Donors; (iv) New TRF Major Donors; (v) New TRF Bequest Society Members; and (vi) New LJGTRC Foundation Members. After explanation by Pam Russell, the Board reviewed, and had no objection to or questions about, **Exhibit 7b** which constitutes the summary and breakdown of every Club member as to their participation in the all of the above Life to Date. Board reviewed, and had no objection to, or questions about, **Exhibit 7c** which specifies any Polio Plus Contributions of \$1,000 or more from July 1, 2018 through June 30, 2019.

- **8.** Board reviewed, and had no objection to, or questions about, the revised **Exhibit 8** (attached hereto as *Exhibit "B"*) that reflected the FY 2018-19 AOS previously approved funding.
- 9. The Board reviewed, and had no objections to, the Fund Advisor Statement from the San Diego Foundation (Exhibit 9). However, the Board did have questions and a discussion about the corpus owned by the San Diego Foundation. Linda asked if the San Diego Foundation provided more background information to us in addition to the Statement. Pam agreed to add that additional information to be distributed to the Board annually. Alex explained his new role for the Club for RI Foundation matters, and Pam agreed to include Alex in the distribution list for all information Pam receives from the San Diego Foundation. Steve provided a history of the reasons for the creation of our Foundation and the prior decision to transfer the corpus to the San Diego Foundation. Steve explained to the new directors and visitors that it is important to realize that our Foundation does not "own" the corpus but only is the beneficiary of earnings realized from the corpus. Consequently, the San Diego Foundation "owns" the corpus for the benefit of our Foundation. Steve explained that was an intentional decision made many years ago to remove any temptation by the leadership of the Foundation to invade the corpus for Rotary projects, but instead grow the corpus for the long term benefit of the Club in perpetuity. Eric explained that our Foundation is limited to giving guidance to the San Diego Foundation as to which investment strategy we wish the San Diego Foundation to utilize in connection with the investment of the corpus, and our Board has consistently selected the guidance consistent with a private charitable foundation acting in accordance with the prudent investor rule. In prior years the Board has had many discussions about whether we might change the guidance in order to obtain better returns by selecting a difference guidance and consistently agreed that the guidance consistent with a private charitable foundation acting in accordance with the prudent investor rule is our best course of action and consistent with our fiduciary duties as directors of our Foundation.
- **10.** M/S/C that all email votes by the Board in the prior year were formally ratified and approved, including but not limited to those email votes specified on a revised **Exhibit 10** attached hereto as *Exhibit "C"*.
- 11. The Board reviewed, and had no objections to, or questions about, the engagement letter between the Foundation and F C Payroll & Accounting (Exhibit 11).
- 12. Steve discussed the status of the Baumgartner Bequest to the Foundation for a partial interest in the remainder of that trust that will be distributed to the Foundation endowment many years from now. The current value of this future distribution was valued at approximately \$900,000 but will diminish substantially as future distributions are made to lifetime beneficiaries with the result that we are unable to set any timetable as to when monies will be distributed to the

Foundation or the actual amount to be distributed other than to conclude it will be substantially less than its current valuation.

- 13. Linda told us that the Club has not been a financially robust as in the past, and wondered if it would be prudent for the Club Board to revise its current policy to pay for any wire charges incurred by the Foundation, and the directors agreed it would be prudent for Linda to ask the Club Board to revise that policy. The directors agreed we would only ask the club to pay for wire fees incurred in excess of interest income received. The directors also thanked Linda for her prior foresight in having the Club Board agree to pay for the CPA cost to prepare the Foundation's tax return and Linda agreed she would not ask for any change in that policy.
- 14. Tony inquired if we needed to reevaluate the legal consequences of the Foundation's Consulting Contracts with Fary Moini dba Moini International Consulting ("Fary Consulting Contracts") in light of recent changes in California law. Eric responded that was an issue he had never thought of until Tony brought it up and thanked Tony for his wisdom. Eric and Steve agreed to attempt to resolve the issue to remove any potential liability to the Foundation as a result of the possibility that notwithstanding the intention that Fary is acting as an independent contractor under the Fary Consulting Contracts, under new CA laws she might be considered to an employee.

#### **15.** New Business:

- a. Steve told the Board that in December, 2019 our club foundation received \$10,500 from the William H. Donner Foundation. \$7,000 is to support pediatric cardio surgeries' transportation costs of Afghan youth and escorts to travel to and from India for the surgeries. \$3,500 is to start up a female cricket sports program in some of Jalalabad's (Afghanistan) public female high schools. M/S/C to approve the receipt and expenditure of said funds consistent with these projects.
- b. <u>Email Votes</u>. Eric advised the Board that the email votes are not consistent with California law, and best practices would require a meeting for each vote. The Board agreed that given the de minimis nature of most email votes, we would continue with the email votes and annual ratification process we currently utilize. Eric agreed that in the event of a non de minimis vote, he would call for a meeting.
- c. Eric advised the Board that the Copley Foundation has agreed to fund \$11,000 annually to our Foundation for military related projects. In response the Board passed the following motion:

M/S/C to approve the use of the Club Foundation to collect grants in varying amounts from the David Copley Foundation which our Club Foundation will use to fund various projects for the benefit of the military based in San Diego County under the guidance of our Club and

utilizing volunteers from our Club and others, and not requiring the expenditure of any Club Foundation assets other than the grants received from the Copley Foundation or third parties.

d. In recognition of the need to start preparing for future transitions in our leadership Pam has thoughtfully started to prepare an Operations Manual and we will all be asked to provide input as we work through that Manual.

There being no further business, the meeting was adjourned at 10:07 AM.

The current value of this future distribution was valued at approximately \$1,052,097.00 but will diminish as future distributions are made to lifetime beneficiaries with the result that we are unable to set any timetable as to when monies will be distributed to the Foundation.

#### 13. New Business:

- a. Mysterious \$5,000 Check. Steve advised the Board that the Foundation received a check for \$5,000 from a Donor Advised Fund with US Bank but with no designation as to what the money was to be used for. M/S/C to wait until March 1, 2019 to see if any further directions are received as to the use of the money, and if not Steve will deposit the \$5,000.00 into the Foundation Account at San Diego Foundation.
- b. Villis Pledge. Steve discussed a Gift Agreement between the Foundation the Villis Family Legacy Fund at the San Diego Foundation established by Cynthia Villis. Pursuant to this Gift Agreement, to the extent that the Foundation receives funds from Cynthia's Fund from the Donor Fund, the Foundation has agreed that such funds shall be used for grants to The Rotary Foundation of Rotary International for scholars studying at Joan B. Kroc School of Peace Studies at the University of San Diego ("USD Kroc School of Peace Studies"). Furthermore, in the event that the USD Kroc School of Peace Studies ceases to exist, then in such event, Cynthia desires (and Foundation has agreed) that the Foundation shall distribute all received funds from (i) 50% to the Office of the Provost at USD, and (ii) 50% to be utilized for Club Projects of the La Jolla Golden Triangle Rotary Club.
- c. <u>Caster</u>. Steve has had discussions with Terry Caster as to the potential of a grant to the Foundation to be used to support current projects of our Foundation in Afghanistan which might be \$100,000.00 annually for a total of ten years for a total of \$1,000,000.00. This is tentative and might not happen.

If it does happen, Steve and Susan will match \$50,000.00 for each \$100,000.00 from Mr. Caster.

- d. Club Members Donating to RI Foundation or Club Foundation. This FY, seventeen (17) Club members did not contribute either to the RI Foundation or our Club Foundation. Steve will work with Alex to see if that number might be able to be reduced with only no-pressure discussions.
- e. <u>Succession</u>. Recognizing that younger Directors will be essential to the long term health of our Foundation, our esteemed Antonio announced his resignation as a Director of our Foundation. Antonio's wisdom and grace will be missed.
- f. Election of Luke Ervin. M/S/C to elect Luke Ervin as a new director to replace Antonio.
- g. Website. Steve wanted to remind all Directors that he has established "archive" web site maintained by an outside vendor for the benefit of the Foundation. All corporate minutes have been posted to this website as have tax returns going back to 2011 as well as Foundation state and federal tax determination letters. Annually Steve posts the Foundation's last tax return and most recent minutes. 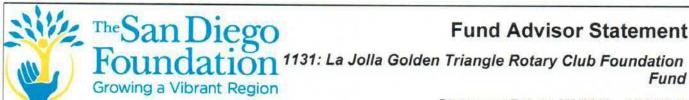

The following is an engagement letter regarding tax return services for the tax year ended June 30, 2019. Based on your previous activity we anticipate that you will be required to file the more complex Federal Form 990 for the year ended June 30, 2019.

We will prepare federal and state income tax returns with supporting schedules for the tax year July 1, 2018 through June 30, 2019 based on information you furnish to us. We will provide accounting assistance as necessary for preparation of the income tax returns. We will not audit or verify the data you submit, financial statements from the information provided to us. Our work does not include any procedures designed to discover fraud, defalcations or other irregularities, should any exist. You are ultimately assets and the substantial accuracy of the financial records. You should retain all the documents, canceled returns for four years, but not the supporting data.

We will use professional judgment as we prepare the returns. Whenever we are aware that applicable law is unclear or that there are conflicting interpretations of the law by authorities, we will explain the possible positions which may be taken on your return. We will adopt whatever position you request, so long as it is consistent with the codes, regulations and interpretations of the courts. If the government should later contest the position taken, there may be an assessment of additional tax plus interest and penalties. We assume no liability for any such additional penalties or assessments.

Attached is a list as well as an informational questionnaire regarding what we need from you in order to prepare the tax returns. This needs to be completed and signed by a representative of management.

We expect to complete the income tax forms 990, CA199 and RRF-1 in October, assuming we have all the necessary information by August 31, 2019. The returns are due by November 15, 2019. Regulations strongly recommend that the Board review and approve the tax returns, prior to having an officer sign and submit them to the taxing authorities. In order to have time to do this and document the approval in your minutes, we may need to file an extension.

Our fee for these services is based on our regular hourly rate of \$125/hr., discounted for your nonprofit status, the complexity of the returns and the condition of your records. Based on last year's income tax returns, and the need to complete the more complex form 990, I estimate your fee for this year is approximately \$1,500 and will not exceed that amount. We may extend a discount depending on the condition of your records and the promptness of your responses to our questions. The nonprofit discount will not be applied if these returns go on extension due to failure to provide us information in a timely manner. Payment for services rendered is due upon receipt of the returns.
